NON-REFUNDABLE DEPOSIT ¶ A non-refundable deposit of 10% per child is required by May 1, 2010 to hold a place for the 2010 - 2011 academic year. This amount will constitute the first tuition payment for the academic year.

LATE PAYMENT ¶ Please note that payment is due on the 1st day of each month. DCS will apply a late payment charge of \$50 per child for payments not received by the 10th of each month. Prompt payment will be greatly appreciated.
